## General Safety Rules

- Display Baker Hughes/Visitor badge at all times. Return visitor badges and sign out upon leaving the facility.
  - Safety glasses with side shields must be worn in all supply chain areas (and other areas as required).
  - Steel-toed safety shoes must be worn in all supply chain(non-office) areas. The exception is that closed-toed shoes can be worn in clearly marked designated aisle ways.
- 
- Shorts and Sleeveless Shirts are not permitted to be worn while in all Supply Chain areas.
  - Smoking is not permitted in the facility. Your host can direct you to one of the designated outside smoking areas if needed. These are located on the northwest and southeast corners of the building.
  - Additional HSE and Security rules and procedures may apply based on your activities at the facility.

## In Case of EMERGENCY



- For minor injuries that require First Aid, ask your host to contact an ERT member for treatment. All injuries and safety incidents must be reported to your Nexus Controls contact.
- For medical, fire, and other emergencies **Dial 2811** to page the Emergency Response Team (ERT). **THIS IS A PAGE # AND YOU WILL NEED TO ANNOUNCE WHERE THE EMERGENCY HAS OCCURRED IN THE FACILITY.**
- If Outside Emergency help is needed Dial 911.
- SEVERE WEATHER/TORNADO: If severe weather threatens the facility and you are instructed to report to the tornado/severe weather shelter, promptly move to the interior of the building and make your way to the Steamboat CR/Library area located in the Southeast office area of the facility.

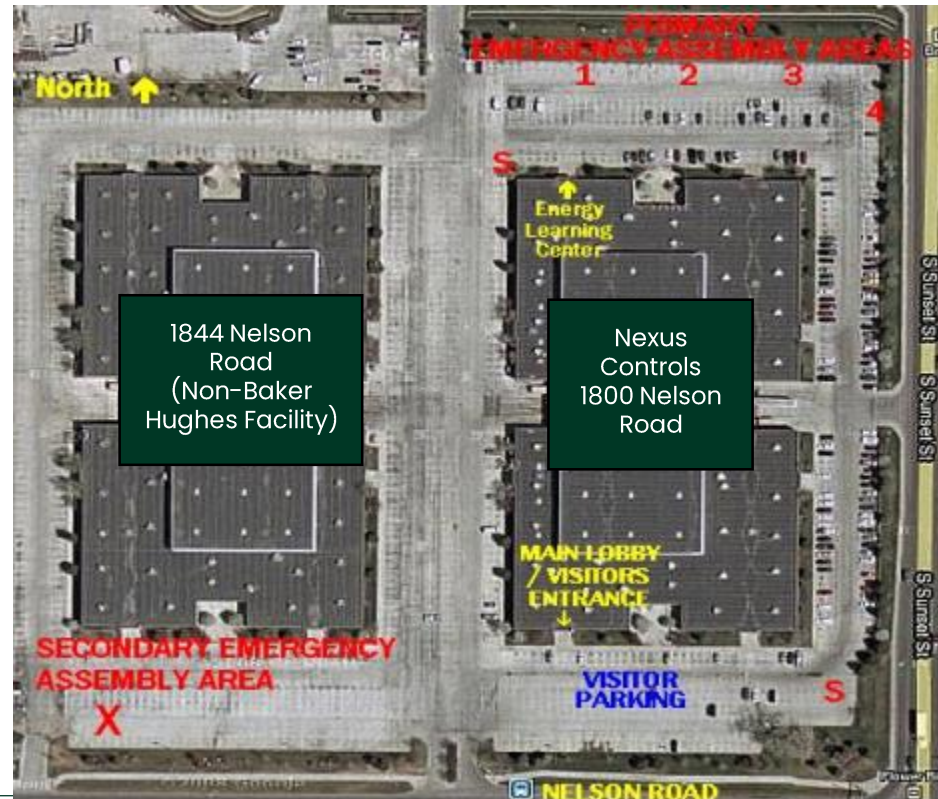
## EVACUATION

- If the fire alarm system is activated or an announcement is made over the PA system to evacuate the building, evacuate immediately by the nearest exit and proceed to the Primary Emergency Assembly Areas at the North end of the facility.

## PRIMARY EMERGENCY ASSEMBLY AREAS

- Southwest Office Area and Visitors
- Northeast and Northwest office areas (includes the ELC)
- Supply Chain in the High-Bay Area
- Southeast Offices (Technology)

## PARKING LOT AND TRAFFIC

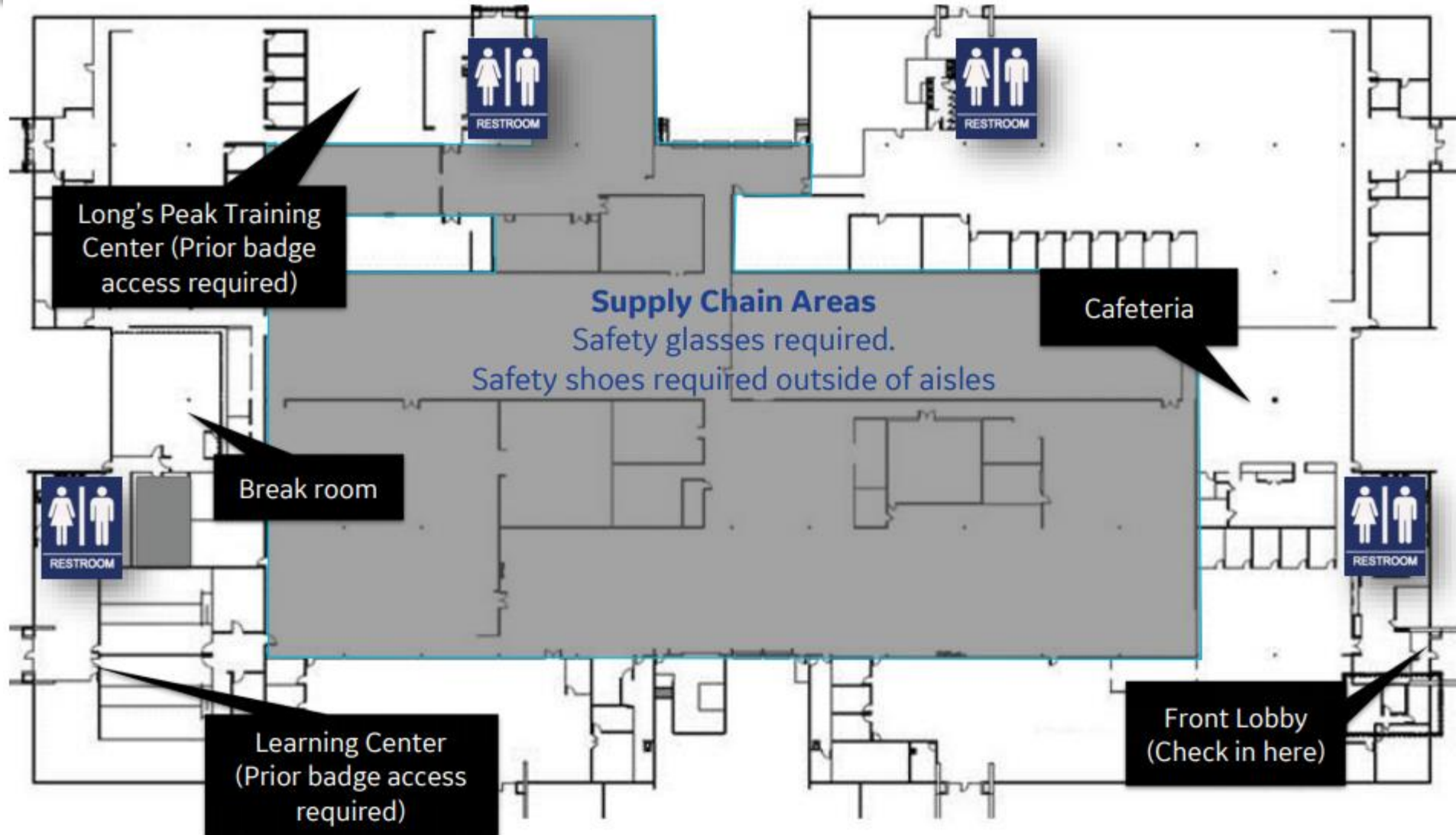
- Parking areas surround the facility. Access to the parking lot is via Nelson RD, or Sunset St. Maintain your speed at 10 MPH or less.
